## COVID-19 REQUIREMENTS AND TESTING

### TRAVELLING TO ANTIGUA

The Government of Antigua and Barbuda has updated its travel advisory to ensure the continued safety of visitors and residents. Protocols have been implemented including but not limited to:

- Entry restrictions have been implemented for all persons who have travelled to the following countries within **fourteen (14) days** of intended arrival to Antigua and Barbuda: **Brazil, India, and South Africa.**
- **Non-Vaccinated** arriving passengers must have a negative COVID-19 Real Time Polymerase Chain Reaction (RT-PCR) test for SARS-CoV-2 using a nasopharyngeal swab taken within **seven (7) days** of their arrival to Antigua.
- **Vaccinated** arriving passengers must have a negative COVID-19 Real Time Polymerase Chain Reaction (RT-PCR) test for SARS-CoV-2 using a nasopharyngeal swab taken within **seven (7) days** of their arrival to Antigua.
- All arriving passengers must complete a Health Declaration Form which will be issued on the aircraft or by the Antigua Port Authority and will be subjected to screening and temperature checks by Port Health Authorities upon arrival to Antigua and Barbuda.
- In addition to the above, all guests arriving to Jumby Bay Island who have had a pre-stay at an on-island location, or on a private yacht, **must either:**
  - a) **Provide an additional negative Rapid COVID-19 Antigen test result if your initial COVID-19 RT-PCR test result (presented on entry to Antigua) is less than 7 days old.**
  - OR**
  - b) **Provide a new negative COVID-19 RT-PCR test result if your initial COVID-19 RT-PCR test result (presented on entry to Antigua) is more than 7 days old.**

All the above is applicable to any guest over the age 2yrs arriving to Jumby Bay Island. In addition, all arriving passengers must observe all protocols during their stay such as the wearing of a face mask on disembarkation of aircraft, and in all public areas in the airport as well as throughout Antigua and Barbuda and adhering to social/physical distancing protocols. During the stay it is mandatory that only Covid-19 certified businesses such as restaurants and excursions are patronized.

All arriving passengers will be monitored for COVID-19 for periods of up to 14 days in accordance with the directions of the Quarantine Authority and the Quarantine (COVID- 19) Guidelines.

Visitors may be required to undergo testing for COVID-19 on arrival or at the hotel or place of lodging as determined by the Health Authorities and may be subject to quarantine as determined by the Quarantine and Health Authorities. Arriving passengers with symptoms of COVID 19 may be isolated as determined by the Health Authorities.

## DEPARTING FROM ANTIGUA

Jumby Bay Island facilitates seamless COVID-19 testing for our departing guests.

### COVID-19 RT-PCR testing:

- Guests who need this test are asked to register and pay online [here](#) via the Mount Saint John's Medical Center (MSJMC). This must be done at least five (5) business days prior to departure from Antigua, in order to secure an appointment.
- Once the appointment is confirmed by the MSJMC, testing will be conducted on Jumby Bay Island.
- In order to facilitate on-property testing there is a swabbing fee of \$50 per person, which will be applied to the final guest bill.
- Results are emailed directly to guests from the MSJMC.

### COVID-19 Antigen (rapid) testing:

- Guests who need this test are asked to contact the Resort Concierge at least two (2) business days prior to their departure from Antigua.
- COVID-19 Antigen (rapid) testing is conducted on Jumby Bay Island on Mondays, Wednesdays, and Fridays.
- There is a fee \$170 per person, which will be applied to the final guest bill.
- In order to confirm a testing appointment, we require a copy of guests' passport bio pages and return travel itineraries.
- Results are available within 45 minutes and are emailed to guests by the Concierge within 2hrs.
